

# Rules of the contest "Win your travel budget for 2021!"

## **Article 1: Organisation**

TUI Belgium N.V., with registered office at Gistelsesteenweg 1, 8400 Oostende (Belgium), VAT BE 0408.479.965, hereinafter referred to as 'the organiser', organises a contest commencing on 22 December 2020 and ending on 3 January 2021 at 11.59 pm.

## **Article 2: General information**

The contest is exclusively governed by these contest rules. By participating in the contest, the contestant accepts the contents and all provisions of these rules as well as any decisions the organisers may make to ensure the smooth running of the action. Except for the participation and the announcement of the winners, no communication in writing or by phone will take place with respect to the contest. The organisers reserve the right to interrupt, amend, shorten or cancel the contest, its rules and/or its course. In such cases they cannot be held liable.

## **Article 3: Participation**

Participation in the "Win your travel budget for 2021" contest is open to any natural person (at least 18 years of age) with a permanent address in the EU or Morocco who agrees to these rules via the online registration form, with the exception of staff members of TUI Belgium nv and their family members. Only one participation per household living at the same address and per e-mail address is allowed. Multiple or fraudulent participations will be considered invalid and disqualified.

In order to participate in the contest in a valid manner, contestants need to take the following steps:

2. Provide the right answers to the questions.
3. Answer the elimination question.

## **Article 4: Prize**

The prize cannot be exchanged for cash or any other benefits in kind. The prize cannot be traded or converted into cash.

#### **Article 5: Determination of the winner**

The winner of the contest is the legitimate participant who answered all questions correctly and who gave a correct answer to the elimination question. If none of the participants answered the elimination question correctly, the winner of the contest is the legitimate participant who answered all quiz questions correctly and whose answer to the elimination question is closest to the correct answer. If there are several participants who gave the correct answer or the answer that is closest to the correct answer to the elimination question, the participants who answered the questions quickest are the winners.
